As I write this article I am sitting in Oklahoma at the NCED in Norman where I am attending week 8 of the Management Essentials for the Field Leadership Program. Last month was very productive. I and many of your fellow managers went attended the legislative advocacy days in Washington, D.C. While there, we were briefed by both the Postmaster General and the Deputy PMG regarding our financial shape and where we needed to push for legislation. Postal mangers cannot lobby congress, but we as an organization can. As is her style, PMG Brennan spoke in an honest fashion, commending us for our successes, but explaining there was more

to do. Afterwards she had time for questions. I was able to get to a microphone and first tell her how much we appreciated all of the leadership training that she has made available to us. I then told her about the disconnect between what Postal Headquarters' vision is and what is filtered down to the field. I told her that the engagement we are being taught is not always the engagement we are receiving. I suggested that perhaps the MEFL class should start with the AVP's.

CONGRESS.

After we were briefed by the UPMA leadership, we hit Capital Hill for a day of going door to door to tell our congress people and/or their aides just what the postal service will need to survive going into the next decade and beyond. We need a postal bill that makes financial sense, while being fair to postal employees. We need regulatory reform in the areas of benefits and product offerings. We need overpayments applied to reduce and eliminate our debt. We need ACTION NOW! Recently the Post office defaulted on a \$6.8 billion dollar pension payment. The first such payment they have ever missed. Cash is tight and the PMG rightly decided to retain cash in order to run the business. For the most part we were greeted cordially, if not warmly. We received a lot of "nodding heads" and "yes we understand," but few promised to push the other side for the passing of this bipartisan bill. There was, as always, the blame the other side approach. This needs to change and our PAC donations will help to support those that help move our cause forward.

RITA.

Finally I want to mention Rita. If we had Rita on our retail windows we would never have a line. She is a transit worker in DC and took pity on a bunch of out of place New Jersey Postmasters who were clueless as to how to buy metro cards. Rita took over. Within 3 minutes 10 of us had the fare we needed to be on our way. A big thank you to Rita! Many of our employees go the extra mile daily as well. Don't forget to thank them. I hope to see everyone at the state convention in May.

Past President's Message

I am reminded of the quote by Czar Nicholas of Russia prior to the beginning of the first World War. He was commenting on the rapid decline of the once mighty Ottoman Empire. He referred to them as "the sick man of Europe." Unfortunately for all of us, the Postal Service has become that "sick man". Our revenue losses are staggering as they measure in the billions of dollars. Take into consideration also that our mail volume has seen an unprecedented and precipitous loss in volume - probably somewhere in the range of 1.8 billion pieces. Couple those two things, and it is not difficult to see that unless something changes, we have a couple of seats on the Titanic. It's just a matter of time before we go down with the ship. Something must change, and it must change fast.

How often have we heard Megan Brennan, our PMG speak of finances? In my experience many people have heard so many people speak concerning our finances that they have become calcified to its message. In short, people tune it out. All too often people simply refuse to believe the direness of a situation until it is too late. They simply believe that life will continue as always. Rome is about to be sacked by the Gauls, and we are too busy feasting.

I have had the privilege of speaking with Ms. Brennan on several occasions. What I find most appealing about her is her absolute genuineness. She really cares for people. The last time we spoke was at the Postal Museum in Washington D.C. She asked me how I was doing. Her first words upon talking to me were to see how I was doing. It wasn't anything related to the Postal Service. It was about how I was doing. That's what I meant about her genuineness. I sighed heavily, and told her about my father's ill health. There was an immediate pained expression on her face, and she reached out to me, laid her hand on my forearm and said how deeply sorry she was to hear of it. I haven't forgotten it. More than anything else, her first reaction was empathy. It had nothing to do with the Postal Service, or anything else we could have possibly been discussing. It was about me as a person. For me, that's the epitome of Employee Engagement. I cannot fathom the weight upon her shoulders as she tries to make the case for Postal reform. It's a weight that must seem unbearable at times, and yet her first reaction is always about a person's welfare.

What all of us must do is to take up the mantle for her, and to write our Congressmen and Senators about the dire circumstances in which we find ourselves. What I find absolutely apoplectic is that Congress seems oblivious to the situation. The Postal Service is one of the largest employers within the United States, and yet Congress is too busy feuding with themselves to really take note of what really matters - the one entity that touches base with every household in the United States every single solitary day, sometimes on Sundays, too. In short, we seem to have been relegated to the lowest position on the totem pole, so to speak. That must change if we are to survive. We need to write to them and voice our support for H.R. 756, a bill that will save us \$29 billion in projected savings in the next five years. Whenever I tell people to write their Congressmen and Senators, I am sometimes met with eye rolls. People seem unaware of how ominous the situation really is. We have to try to make a sightless Congress actually see. Abraham Lincoln once said, "The probability that we may fail ought not to deter us from the support of a cause we believe to be just." Whether or not we fail in our endeavor should not prevent us from doing it. Unless we get them to listen, Ms. Brennan may be forced to go down a road none of us wants. Status quo is not an option any more.

No entity can continuously sustain the losses we have. Christina Rossetti wrote of an early, untimely death. For the first time in my career, I am deeply worried. The cost of sustained immobility on our part will only facilitate the death of the Postal Service as we know it, and we will only have ourselves to blame. (Continued on page 4)

Why you may ask? Because I see too many newer higher level managers writing up Postmasters, Managers, and Super-


visors for things that should have been a teaching experience and not punitive.

We spent the entire morning until early afternoon on Tuesday, February 27 meeting with our respective congressional district's members and their aides. We clearly outlined the points made on our Legislative Advocacy Summary, which you can find in its entirety on pages 18 and 19 in this edition.

After lunch, we were greeted at Postal Headquarters for our previously scheduled tour of the Social Media Center. Our official tour guide and the entire Social Media Team couldn't have been more hospitable as they willingly explained the process and answered are inquisitive questions. While at postal headquarters, we were fortunate enough to bump into, our friend, the Postal Historian who offered a glimpse into the enormous past of our great service, while we gazed out the spectacular view of Washington, DC from the postal library's windows.

Our trip concluded with a private, guided tour of the Bolger Center and its training facility by one of our favorite postal inspectors. Thus, you understand why I stated that we left no stone of opportunity unturned. This year's summit was clearly reflective of the enormous amount of work and preplanning that goes into making the most of our advocacy visits to Washington, DC. Recognized as my most favorite of the national events, the Legislative Advocacy Summit continues to provide us with a chance to openly discuss our organization's and our service's positions on matters of legislation, while making the most of the resources in the area. If you weren't able to join us this year, I ask that you make every effort to join us for next year's 3rd Annual Legislative Advocacy Summit; an event surely not to miss!

Who was Airmail Pilot Bill Hopson?

Hopson had 741 hours of flight time when he became an airmail pilot on April 14, 1920. In 1925, base pay for beginning airmail pilots was \$2,000 to \$2,800, depending on how much night flying they did. Pilots also earned five to seven cents per mile flown, double for night flight. Pilots agreed, in writing, to fly in all kinds of weather. Hopson's last flight for the Department was on August 27, 1927. Hopson died October 18, 1928, when his plane crashed into the top of a tree on a hill near Polk, Pennsylvania, during a bad storm.

Senate Postal Bill (S. 2629) Introduced Posted on UPMA National Website by Bob Levi

On March 22, 2018, Senators Tom Carper (D-DE), Jerry Moran (R-KS), Heidi Heitkamp (D-ND) and Claire McCaskill (D-MO) introduced S. 2629, the Postal Reform Act of 2018. The legislation is the Senate version of HR 756, the House postal reform bill. H.R. 756 was approved by the House Oversight and Government Reform Committee last year. S. 2629 shares most of the core provisions of H.R. 756; however, there are key differences.

Both bills would integrate FEHBP and Medicare coverage for Medicare-eligible postal retirees in order to reduce the Postal Service's health care liability. In addition, both include a 3-year USPS premium subsidy for newly enrolled Part B beneficiaries. However, S. 2629 includes three waivers of Medicare Part B coverage: (1) financial hardship, (2) Veterans Administration health coverage and (3) the lack of Medicare providers in the retiree's area of residence.

Both bills call for a more accurate calculation of the USPS' pension liability. In addition, both bills would amortize USPS' remaining health care liability. While H.R. 756 would amortize 100 percent of the remaining liability over the next 35 years, S. 2629 would amortize 80 percent over the next 40 years; the remaining 20 percent would be secured with future postal property sales. (S. 2629 would not require the sales.) S. 2629 would establish a procedure for the USPS to seek waivers from its annual amortization payment through the Postal Regulatory Commission. The Senate bill would also offset the increased Medicare obligation through a one-time \$13 billion transfer of funds from the account in which amortization payments have been deposited in the past to the Medicare Trust Fund.

Both bills would reduce the number of presidential-nominated Board of Governors from nine to five, would make the Postal Inspector General (IG) a presidential appointee, would create a Chief Innovation Officer within the USPS, and would reform the way in which the USPS awards vendor contracts. Both bills would restore one-half of the exigent rate increase that expired in April 2016. S. 2629 would also require the Postal IG to conduct a study relating to the rates charged to "underwater" postal products (i.e., magazines), and would require the USPS to submit to Congress a plan for its long-term solvency.

While H.R. 756 would authorize the voluntary conversion of residential mail deliveries from door delivery to alternative locations (e.g., curbside and cluster boxes) and phase in alternative deliveries for business addresses, S. 2629 contains no delivery conversion language. S. 2629 would permit the shipping of wine, beer and spirits.

Both HR 756 and S. 2629 would expand MSBP appeal rights for EAS level employees and would suspend further post office hour reductions and post office re-classifications, pending an IG report on POStPlan. In addition, S. 2629 would require an IG report on USPS compliance with the statute governing "consultations" and EAS pay talks.

Upon introduction of S. 2629, UPMA Co-Presidents Tony Leonardi and Sean Acord commented: "The United Postmasters and Managers of America (UPMA) applauds the efforts of Senators Carper, Moran, Heitkamp and McCaskill in introducing bipartisan legislation to further the goal of providing financial relief to the U.S Postal Service. UPMA looks forward to continue working with these Senators and other members of Congress to sustain the U.S. Postal Service, a proven national treasure."

The 2018 UPMA national legislative conference in Washington, D.C. was a great experience for more than three hundred participants representing their state and territorial organizations. It was gratifying to hear the enthusiasm members have for UPMA's efforts to improve the conditions under which postmasters are contending with daily challenges in their offices. These include some issues that impact delivery efficiency and customer satisfaction. Others relate to cultivating revenue opportunities at the state, district or local levels and encouraging our members to support business sector exercises like the Postal Consumer Councils.

What especially stood out was the unfaltering interest by postmasters in working toward legislative, reform-based solutions to policies and practices that obstruct the USPS's ability to grow as a presence in the business community and others that threaten postal benefits that employees have worked for and upon which they and their families have made financial decisions through their careers. Certainly elimination of the annuity supplement and the proposal to increase our FERS contributions

by one percent per year for six years could have a tremendous impact on retirement plans and take home pay.

Some very positive highlights from the conference included speeches and question and answer sessions by Postmaster General Meghan Brennan and Deputy Postmaster General Ronald Stroman. Much of the exchange with the PMG had less to do with our legislative agenda than with operational issues and Ms. Brennan was responsive and encouraging. She confirmed her commitment not to abolish level 18 postmaster positions unless the incumbents retire, pledged progress on the issue of vehicle replacement and intervention in practices reported by numerous participants of corrective action issued to meet arbitrary district and area training dates in preference to real date targets set by Washington. Her willingness to stay and answer all the questions her schedule would allow was appreciated by the UPMA members present.

Bob Levi, the UPMA legislative liaison, conducted a four hour conference on Monday afternoon at an auditorium at the Capitol Hill Visitors Center that focused on the status of proposed reform legislation including H.R. 756. Bob works as UPMA's point player in Washington and provided an experienced perspective during the advocacy training session. Two members of the House of Representatives, Mark Meadows, a Republican from North Carolina who is a member of the House Committee on Government Oversight and Reform which will control most postal reform legislation and Jamie Raskin, a Maryland Democrat, shared their view that for change to occur this year, legislation needs to come to the House floor in March or April before focus on the midterm elections and other issues cause the urgency for change to recede in the minds and priorities of congressional representatives. The convergence of views of a conservative Republican and liberal Democrat in general terms on postal legislation reflects one of the frustrating realities in the postal debate: the fact that there seems to be widespread agreement across partisan and ideological lines about the need for postal reform but little political will to act on it.

Our visits to New Jersey House members and their staff representatives the following day echoed the perception of representatives Meadows and Raskin. Legislation in some form acceptable to UPMA's interests can pass this Congress. Special thanks go to Congressmen Albio Sires, Leonard Lance and Bill Pascrell for meeting with us personally and pledging support. Frank Lobiondo, Bonnie Watson Coleman provided guarantees of support through their staff members. But we need to keep pressure on those who represent us to build and maintain focus on H.R. 756 and other goals for this year. The precarious character of our present business and employment plan is no promise for the future.

But to end on a more positive note, my personal thanks go to the UPMA members who came along to add their voices to our efforts in Washington: Dave Sparano, Bernadette Puodziunas, Bill Gleason, Melissa Lomax, Darlene McNamee, Bill Gleason, Tracy Phillips, Cheryl Abaray, Kathy Loguidice and Ted Stirling - our stalwart retiree. Thanks for all the support, interest and laughs over the course of our time together!

United Postmasters and Managers of America 2018 Legislative Advocacy Summary

25,000 Active and Retired Postmasters and Postal Managers Promoting Postal Vitality, Affordable Universal Mail Service and Secure Employee Benefits

Protecting and Enhancing Our National Postal System

The U.S Postal Service is the only entity — public or private — required to prefund its retiree health benefits. (Congress appropriates military retiree health benefits.) Over the past decade, this unique postal obligation has dramatically impaired the operations and finances of the U.S. Postal Service, the security and morale of its employees and services provided to millions of Americans who rely on a first-class postal system.

The agency and its employees emerged from the recent recession seriously wounded by the prefunding obligation. Absent the annual multi-billion-dollar burden, the Postal Service would have realized operating surpluses. (The payment for FY18 was \$6.7 billion.) In a large part, the operating surplus is attributable to workforce reductions and service changes that, regrettably, impacted service to the American public. The lack of measurable fiscal breathing space impairs the Postal Service's ability to modernize operations, invest in capital, energize its workforce, and innovate.

For these reasons, UPMA supports **H.R. 756**, the bipartisan "Postal Reform Act," and looks forward to supporting a Senate version of the bill. UPMA believes such legislation bills would help:

- Lessen the harmful impact of the retiree prefunding requirement has on postal solvency and operations,
- Encourage postal product and service innovation,
- Promote postal pricing that more accurately reflects the true costs of mail acceptance, processing and delivery, and
- Enhance a universal, accessible and affordable governmental postal system.

In addition to the core elements of the bill, UPMA strongly supports provisions to assist Postmasters and Managers of retail postal facilities in making critical improvements and safeguards to postal operations. The measure would help stabilize a nationwide postal network, and sustain rural mail service.

H.R. 756 includes the following key provisions:

- Facilitate equitable calculation of the Postal Service's retiree health and pension liabilities by using postal-specific demographic data,
- Offer relief from the debilitating retiree health liability by coordinating postal retiree Medicare benefits with the Federal Employees Health Benefits Program (FEHBP) and creating a postal-only component within the FEHBP,
- Enhance opportunities for revenue growth by enabling the Postal Service to offer innovative products,
- Provide the Postal Service with needed rate stability and flexibility by reinstituting one-half of the exigent rate adjustment that lapsed in 2016,
- Safeguard quality mail service by implementing a temporary pause on further post office hour reductions or reclassifications of post offices that serve small and rural communities, pending a study by the Postal Inspector General, and
- Provide Merit System Protection Board appeal rights for certain EAS-level employees.

As this document went to press, there was no Senate companion bill to H.R. 756. However, in the previous Congress, UPMA supported Senate legislation, which included many of the same key provisions as H.R. 756.

UPMA supports H.R. 756 and requests its prompt passage; UPMA also urges the Senate to introduce postal legislation promptly and to permit its expeditious consideration.

UPMA Legislative Advocacy Summary - Page 2

Equitable Treatment of Postmaster and Postal Manager Benefits

On February 12, the White House submitted to Congress its FY '19 budget blueprint that, if enacted, would cut more than \$155 billion from programs upon which active and retired postal and federal employees depend. It is important to note that the absence of constructive postal relief legislation and ill-advised operational decisions made by the Postal Service has resulted in early retirements and relocation of many Postmasters, with reductions in pay and job security. Furthermore, Postmasters and postal managers are extremely concerned about the potential use of "budget reconciliation" to offset the cost of new government projects that would reduce pay, or cut earned health and retirement benefits. Therefore, UPMA urges Congress to resist the temptation to use the postal workforce as a means to reduce federal spending or fund other government priorities. UPMA would oppose legislation to:

- Increase employee retirement contributions,
- Eliminate cost-of-living adjustments (COLAs) for Federal Employee Retirement System (FERS) and reduce COLAs
 for Civil Service Retirement System retirees,
- Abolish the FERS Supplementary annuity for postal and federal employees who retire prior to Social Security eligibility,
- · Replace the present formula for calculating the retirement cost-of-living-adjustment with the so-called chained CPI,
- Change the computation formula for the calculating federal annuities from the current highest three-year salary to the highest five-years,
- Eliminate the Federal Employees Retirement System (FERS), and
- Reduce the interest rate used to compute the earnings of the Thrift Saving Plan's G-Fund

Fair Treatment of Civil Service Retirement System Annuitants

Over 30 years ago, two provisions were enacted that unfairly penalized CSRS annuitants: the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO).

The WEP is a one-size-fits-all mechanism that reduces the Social Security benefits of workers who also participate in pension plans from employment not covered by Social Security, such as the CSRS. The GPO reduces a CSRS retiree's Social Security spousal or survivor benefits by an amount equal to about two-thirds of the CSRS annuity. Legislation has been introduced in the both the House and the Senate to repeal the punitive WEP and GPO. Rep. Rodney Davis (R-IL) introduced H.R. 1205 and Sen. Sherrod Brown (D-OH) introduced S. 915. They are both known as the "Social Security Fairness Act."

UPMA would support legislation to repeal the Government Pension Offset and the Windfall Elimination Provision

Postal Governance

Current law authorizes that the U.S. Postal Service be governed by an eleven member Board of Governors. Nine Governors are Presidentially-nominated and Senate-confirmed; they are chosen based on their experience and demonstrated ability to manage large organizations. However, for more than a year, the Postal Service has operated without any presidentially-nominated Governors; rather, the agency only has been governed by the Postmaster General and the Deputy Postmaster General.

The Postmaster General and the Deputy Postmaster General are members of the Board of Governors, but are hired by the Board and not nominated by the president. Postal operations, long-term planning and general governance are seriously hampered without a functioning Board of Governors.

UPMA strongly believes that the President should nominate and the Senate should confirm highly qualified individuals to fill the vacancies on the Board of Governors as soon as possible.

A Letter from Dan Heins, Candidate for UPMA National President



Greetings my fellow UPMA Members,

Soon you will have the opportunity to attend your chapter convention and be part of UPMA history. You will have the opportunity to cast a vote to help determine who the first elected National President of UPMA will be. In addition, you will also have the chance to vote for up to two National Vice Presidents and the chapter officer positions that are up for election this year.

Our UPMA By-laws are specific on how the voting will take. At each of our chapter conventions each active member registered for the convention will receive a ballot. Then the votes will be tallied and based on the percentage cast for each candidate that is how your chapter's electoral votes will be cast at the National Convention in Reno in July. To use round numbers: if there are 30 people at the convention and 20 vote for one candidate and 10 vote for the other, you votes would divided 66.6% for candidate one and 33.4% for candidate two. So, if your chapter has 21 electoral votes, candidate one will receive 14 votes and candidate two will receive 7 votes. As a result, every vote is very im-

portant.

As a candidate for National President, I would like to request that you cast your vote for me. I feel I have the knowledge and experience to serve you as your national president. Over the years I have held numerous positions at both the chapter/state and national levels both in UPMA and in the League and NA-PUS before the merger last year.

Currently, I am serving on the National Executive Board as one of the Vice Presidents representing the western part of country. I am also now serving as Executive Vice President for the Minnesota Chapter. Prior to my current term as National Vice President, I served three years as National Secretary-Treasurer – for two years in NAPUS and then the third year I was a UPMA co-Secretary-Treasurer with Stephanie Jett. That experience has given me the knowledge of the finances and workings of our national organization to prepare me to step in on November 1, 2018, as your president.




